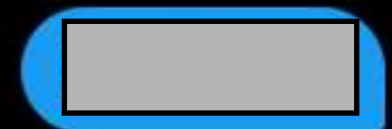

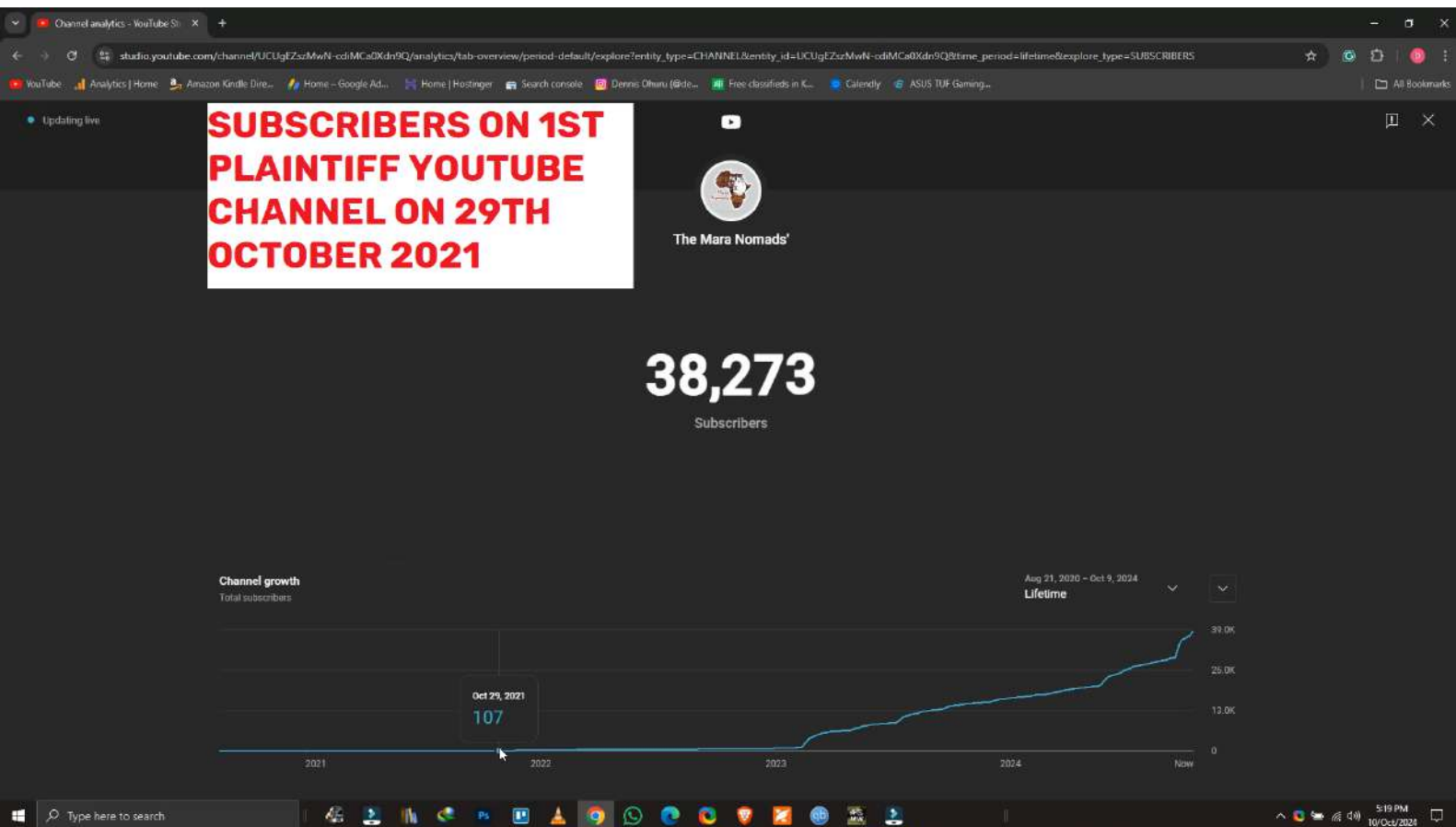

TERMS

1. Dennis Ochieng Ohuru reserves all legal rights as a freelancer and video editor, save for those expressly given to MaraNomads under the terms of this agreement.
2. The cost payable by MaraNomads to Dennis Ochieng Ohuru for video editing shall be 250 Kenyan shillings per video minute of the final video edit draft. MaraNomads shall also reimburse Dennis Ochieng Ohuru transport fees used by Dennis Ochieng Ohuru when collecting unedited video files, and when bringing back the edited videos.
3. Additionally, Mara Nomads will pay Dennis Ochieng Ohuru 500 Kenyan shillings for the design of Youtube Thumbnails.
4. Dennis Ochieng Ohuru and MaraNomads will review the cost of video editing services by Dennis Ochieng Ohuru after a period of 12 months from when the last cost was agreed upon by both parties.
5. MaraNomads is entitled to no video revision under the terms of this agreement. Minor video changes and corrections may be done during the review of an edited video. If a complete video editing revision is requested by MaraNomads, MaraNomads will be liable to pay additional fees of half the value of the final edited video on top of the full final video cost.
6. Dennis Ochieng Ohuru will invoice MaraNomads for the full project fee upon acceptance of the final project by MaraNomads.
7. The project invoice will be due on a net 3 business days basis after delivery of final video edit.
8. Dennis Ochieng Ohuru will require 5 business days to edit simple video projects (Less than 15 minutes final draft) and 10 business days for complex video projects (more than 15 minutes final draft) It is possible that Dennis Ochieng Ohuru MAY complete video edit jobs before this duration of time.
9. MaraNomads will, after a trip, take all the time they need to compile all the unedited video files and present them all together in one occasion to Dennis Ochieng Ohuru. No additional video files will be added to a video once the edit has been done. If additional video files have to be added to the complete video edit at the request of MaraNomads, MaraNomads will pay 500 Kenyan Shillings for each video addition on top of the full project fee.
10. Dennis Ochieng Ohuru reserves the right to use the materials produced during video editing projects as part of a freelance portfolio. This includes music, transitions, effects and all other video editing tools excluding only MaraNomads video files.

11. MaraNomads agrees to indemnify Dennis Ochieng Ohuru against any and all claims, costs, and expenses, including attorney's fees, due to materials used in the video editing projects to which MaraNomads does not possess copyright permission or usage rights.
12. This shall be the sole agreement between Dennis Ochieng Ohuru and MaraNomads. No other agreements, verbal or written, shall be considered binding or valid upon signature of this agreement by both parties.
13. This agreement shall not be modified or otherwise altered unless approved in writing by both the freelancer (Dennis Ochieng Ohuru) and the client (MaraNomads)
14. This agreement can be exited, ended, or cancelled by either MaraNomads or Dennis Ochieng Ohuru by one of the two mentioned parties giving the other a 30-day notice. The notice will be sent via email to the emails provided by both parties in this agreement.
15. At the lapse of the notice period, there being no liability owned by either party to the other. The relationship between the two parties will be determined to have been ended.
16. This agreement shall be governed by the laws of Kenya. Any legal disputes or proceedings shall take place in Kenya.

TO THE MARA NOMADS

Dear Mara Nomads

I would like to start this proposal by stating that it has been a pleasure to work for you editing videos for The Mara Nomads Youtube channel.

It has been 3 years working together. We've had our differences a few times but overall it has been a good 3 years. And the Channel has grown in leaps and bounds since then.

***Our first video « Hiking Mt. Longonot went live on
29th October 2021”***

However, a number of factors have necessitated a rethink on my part concerning the video editing rates I charge to you, they include:

1. My Skill set
2. The cost of living
3. The amount of work
4. Need to level up my Job and reinvest in it
5. My age (I turn 30 in May)

MY VALUE PROPOSITION

1. GROWTH

The Mara Nomads Youtube channel has grown from **350 subscribers** when I joined to **17,700 Subscribers** at the time of writing this letter.

This is a growth of **4,957 %**

2. STORY TELLING

Story telling in video editing cannot be taught, I have mastered the art of storytelling to extract maximum entertainment value from raw video files. As evidenced by the comments received on Youtube.

3. VIDEO POST PROCESSING

Due to the nature of The Mara Nomads niche, the raw video files are massive. I have to watch all of them, convert a large part to 1080p, Pick the best parts, Cut out the bad parts, stitch a story together, find background music that works, add subtitles, add texts overlays, add narration and do revisions.

4. MUSIC LIBRARY

I have over the many months of working together cultivated a music library for the Mara Nomads Youtube channel that evokes emotion and fits with the overall theme of the channel.

Every now and then I add more music to the library to make it richer and more engaging for the audience. Whether that be intro music, outro music, background music, campfire music, sound effects etcetera.

Sourcing this music takes hours of listening to bad music from music libraries on the internet. For every 100 music I listen to, I may find 1 that is useful.

5. THUMBNAIL DESIGN

The first part of a video the audience sees on Youtube is the thumbnail, I have designed a familiar look to the Mara Nomads Youtube channel with a color scheme that attracts attention and clicks and yet is not overwhelming.

THE CURRENT PAYMENT STRUCTURE AND WHY IT IS NOT FEASIBLE

Currently the Mara Nomads pay me for my video editing services as follows;

1. Ksh 200 per minute of final video draft
2. Ksh 500 per minute for thumbnails
3. Ksh 250 for transport

The Last 10 videos on the Mara Nomads Youtube channel are a total of **294 minutes**;

The average video length for the last 10 videos therefore is 30 minutes, for which I receive:

Ksh 6,000 for length, 500 for thumbnail and 250 for transport. ***Totaling Ksh 6,750***

- A 10-minute video takes me roughly 3 days to edit.
- A 20-minute video takes me 6 days
- A 30-minute video takes me 10 days

Therefore, my effective day rate, as it is, equals **Ksh 675**.

This is not attainable with the current cost of living. In addition; I cannot reinvest into my job to make it better.

I am woefully underpaid.

IMPORTANT TO NOTE/ This is not a side hustle for me anymore, it is my Job.

MY PROPOSED VIDEO EDITING RATES

A lumpsum payment structure does not take into the account the man hours it takes to complete any given video edit and it assumes that all video edits are the same.

With that in mind, here are my proposed payment rates;

1. First proposed payment scheme.

Hourly Rate	USD 5 or Ksh 750
Day Rate	USD 30 or Ksh 4,500

The time it takes to edit videos remains the same.

It takes 3 days to edit a 10-minute video. The cost of which is **Ksh 13,500.**

It takes 6 days to edit a 20-minute video. The cost of which is **Ksh 27,000**

It takes 10 days to edit a 30-minute video. The cost of which is **Ksh 45,000**

These rates will be revisited after a net period of 12 months.

2. Second proposed payment scheme.

A monthly salary of Ksh 50,000 on a 1-year contract.

3. Third Proposed Payment Scheme

Ksh 20,000 a month basic salary.

And a bonus system of half of what every new video makes in its first month at the rate of Ksh 0.4 shillings per view. Payable before the 15th of the subsequent month.

So, if a video garners 50k views in its first month after going live;

The bonus will be: Ksh 10,000

50,000 times 0.4 equaling – Ksh 20,000. Half of which is **Ksh 10,000**

This will be revisited after 12 months.

FINAL REMARKS

I have to love what I do for it to be a meaningful enterprise. I cannot love what I do if it doesn't afford me a sustainable livelihood.

MARA NOMADS YOUTUBE MONETIZATION PLAN

BY DENNIS OHURU

Dear Mara Nomads

Following our discussion on my video editing rates proposal.

I was tasked with coming up with a roadmap on monetizing the Mara Nomads YouTube channel.

A move that will help supplement my current video editing earnings and hopefully make my job meaningful and sustainable.

My proposal is Mara Nomads allows me to monetize the channel and keep the earnings therefrom until such a time as both parties (Mara Nomads and I) deem it necessary to change that payment structure or if we part ways.

Here are the monetization options available and my proposal for each.

1. Youtube Ad Revenue (I will keep this)
2. Youtube Memberships
3. Youtube Shopping (Mara Nomads Keeps this)
4. Affiliate Marketing (I will keep this)
5. Website AD Revenue (to be explored and discussed further)

A) YOUTUBE AD REVENUE

Youtube Ad revenue is earnings from advertisement placed on Youtube videos.

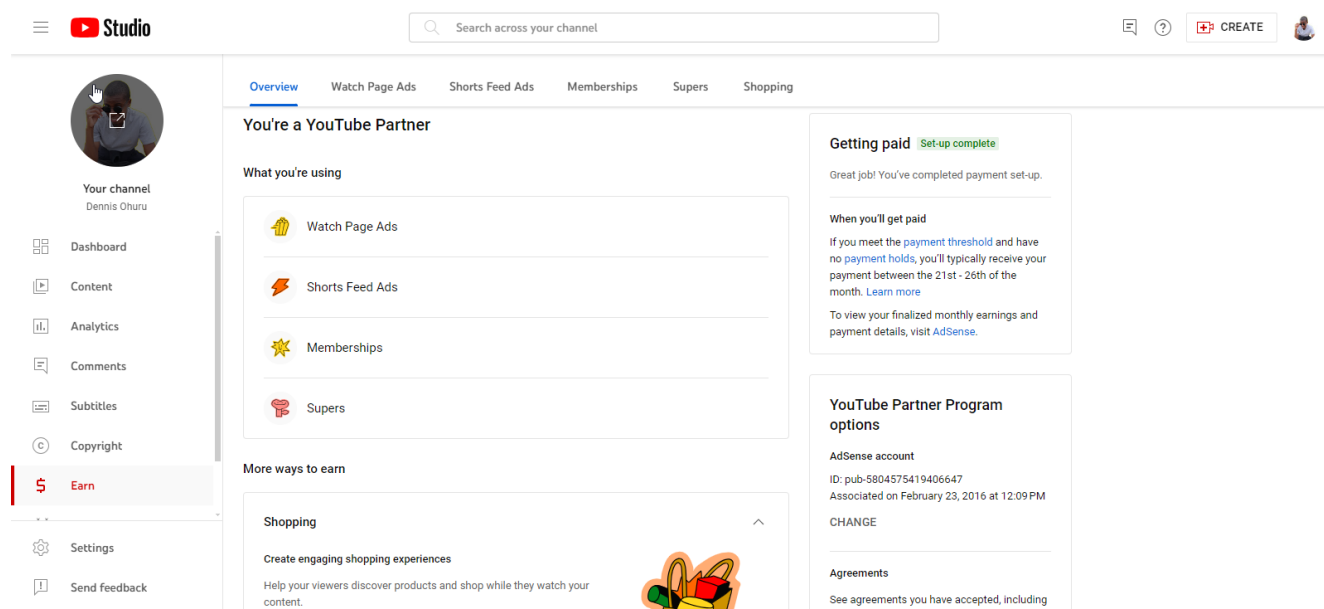
Youtube requires a payment threshold of USD 100 to be reached before they issue a payment of the same.

So, in any given month USD 100 is not reached, the earnings for that month carry over to the following month.

My proposal is Mara Nomads lets me keep Youtube AD Revenue the Mara Nomads Youtube Channel makes until such a time as is deemed necessary by both parties to change that.

HOW YOUTUBE AD REVENUE WILL BE PAID OUT

Youtube pays out all Ad Revenue using a linked google AdSense account.

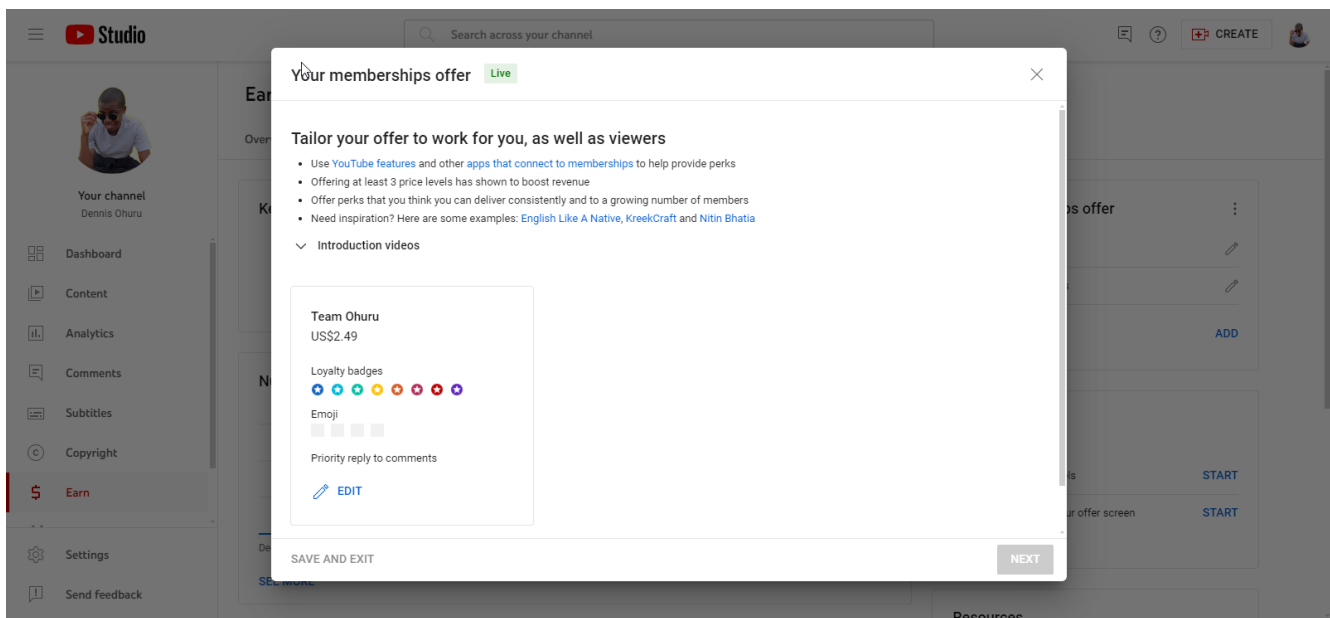
Since I have an AdSense account that is already set up and running, I will channel The Mara Nomads Ad Revenue to that AdSense account.

N/B: This is not a permanent arrangement, the owner of a Youtube channel can change the AdSense account through which Youtube pays them once every 32 days.

B) YOUTUBE MEMBERSHIPS

Channel memberships lets loyal viewers join a YouTube channel through monthly payments in exchange for perks such as:

1. Badges next to their names
2. Emoji
3. Priority replies to comments



My proposal is that Mara Nomads lets me institute a USD 2.49 membership offer on the channel with the above perks.

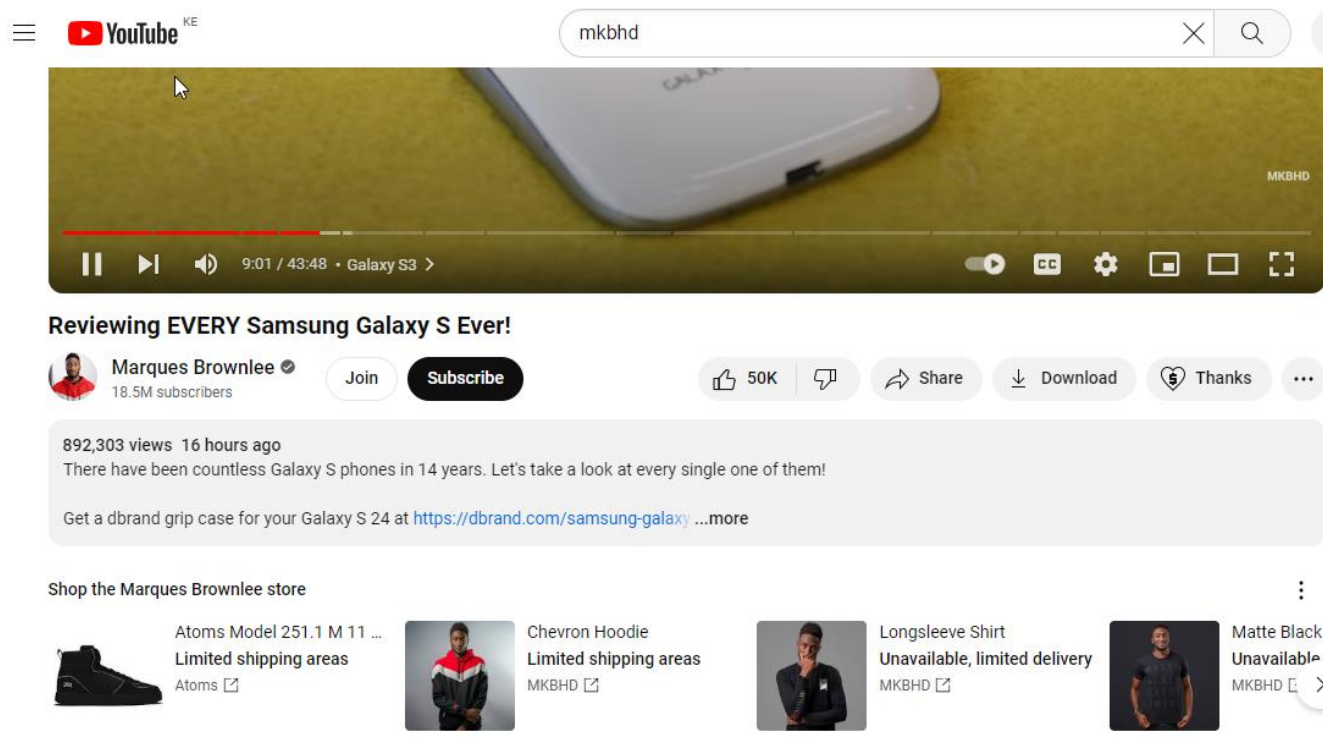
Following that, to give me permissions to be able to reply to any member comments so that “priority reply to comments” is met.

As the Channel membership is a slow revenue source to pick up and grow, we will pay close attention to it and judge its potential.

C) YOUTUBE SHOPPING

Youtube shopping lets channels with more than 15k subscribers showcase their merchandise and products on their Youtube channel for their viewers to browse and buy.

When a viewer clicks on a product, they are redirected to the creator's website where they can purchase the product.



My proposal is to create for the Mara Nomads a webstore using WooCommerce on the Mara Nomads official website. And to add all the available Mara Nomads merchandise to that store.

Interested nomads, coming from Youtube using the YOUTUBE SHOPPING feature can then browse the store and buy their preferred merchandise. Mara Nomads to keep 100% of this revenue stream.

D) AFFILIATE MARKETING

Affiliate marketing is a revenue stream outside of Youtube that can be grown to take advantage of a niched audience.

The most popular affiliate marketing platform and the easiest to implement is Amazon.

My proposal is Mara Nomads allows me to implement an affiliate marketing campaign on the Mara Nomads Youtube channel in the video description after the narrations;

The affiliate marketing links will include such things as:

- 1. Camera gear used by the Mara Nomads (GoPro & drone) so that interested parties can browse them on amazon**
- 2. Tents**
- 3. Outdoor and overlanding gear**

The affiliate marketing campaign can be extended to the Mara Nomads website.

This can be done by allowing me to research on and write useful blog pieces on the above products and using amazon affiliate links to get leads from interested readers on the blog posts.

Of course, blog posts will also attract organic growth from Google search to the Mara Nomads website.

I will keep the earnings from the affiliate marketing campaign but furnish Mara Nomads with detailed reporting of the same every month.
It takes a while to build an effective affiliate marketing campaign.

E) WEBSITE MONETIZATION

There are two ways the Mara Nomads website can be monetized:

1. Website AD revenue
2. Affiliate marketing

Both are dependent on the website getting at least 10,000 page views a month.

My proposal is for Mara Nomads to let me add google analytics to the website.

Google analytics is a tool that allows a website owner (called Webmaster) to study the traffic that comes to the website.

You are able to see the;

- Number of people visiting your website
- The pages they visit
- Their geography
- The devices they use
- Etc

These demographics can then inform whether the website should be monetized or not.

If after a month the google analytics shows that the website receives more than 10,000 pageviews.

We can monetize it.

CONCLUSION

These measures will go along way in helping us understand the monetization potential of the Mara Nomads brand as it grows.

And whatever comes out of the monetization efforts in these early days will go along way in helping to level up my video editing for the benefit of both parties.
